

## **Payment terms**

The following terms (these "Payment Terms") govern payments you make or receive through [www.myblinker.com](http://www.myblinker.com) (the "Site").

Please read these Payment Terms carefully before making or receiving payments through the Site. By making or receiving payments through the Site, you agree and agree, on your behalf or on behalf of your employer or any other entity (if applicable), to be bound by and comply with these Payment Terms.

## **Get paid**

### **General**

- For each service provided, income equivalent to 80% of the amount of the service is credited to the experts.
- MyBlinker credits the capital to the experts once the minimum payout is reached, this would be \$390.
- If a service is canceled (for any reason), the funds paid will be returned to the company, except for the commission of the process expenses, this would be 6%.
- Experts are responsible for paying any taxes, including any VAT or income tax. Experts represent and warrant that they comply, and will comply at all times, with their obligations under the income tax provisions in their jurisdiction.

## **Withdraw capital**

- Experts can withdraw their capital using one of MyBlinker's withdrawal options. To withdraw your available capital you must have the minimum capital of 390 dollars.
- For security reasons, MyBlinker may temporarily disable an expert's ability to withdraw capital to prevent fraudulent or illicit activities. This may be due to security issues, inappropriate behavior reported by other users, or associating multiple MyBlinker accounts with a single payment method.
- Withdrawals can only be made for the total amount you have.

- Withdrawals are final and cannot be undone. We will not be able to reverse this process once it has begun.
- Experts will be able to withdraw capital from disabled accounts after a 90-day security period after full verification of ownership of the account in question.

### **Withdrawal Methods**

- Withdraw to your PayPal account – \$0 fee\*.
- Bank transfer - \$6 per transfer.

### **Acquisitive**

#### **General**

- Payment on MyBlinker can be made using one of the following payment methods: credit card and PayPal.
- The amount to be paid from companies to experts covers administrative fees.
- You may not offer experts to pay or make payment by any method other than the myblinker.com site. In case you have been asked to use an alternative payment method, please report it immediately to Customer Support.
- Payment service providers may also collect any other information that is necessary for the purpose of processing withdrawal payments. MyBlinker is not exposed to payment information provided to Payment Service Providers, and this information is subject to the privacy policy applicable to the Payment Service Provider. Please see our Privacy Policy for more information.
- By using any payment method and/or providing payment details to make payments on MyBlinker, you represent and warrant that: (a) you are legally authorized to provide such information; (b) you are legally authorized or permitted to make payments using the Payment Methods; (c) you are an employee or agent of a company or person who owns the payment method, are authorized by that company or person to use the payment method to make payments on MyBlinker; and (d) such actions do not violate any applicable law.

## **Disputes and Cancellations**

We encourage our companies and experts to try to resolve conflicts between them. If for any reason this fails or if you find an unauthorized use on the Site, users may contact MyBlinker's Customer Support department.

- If the company requests the cancellation of a service (for any reason), 6% will be charged on the paid-up capital, this for administrative expenses.

### **Cancellations**

- MyBlinker encourages businesses and professionals to resolve service disputes mutually in the contact's chat.
- Our customer support team will evaluate eligibility for requests to MyBlinker to cancel a service based on a number of factors, including violations of our Terms of Service, general misconduct, and improper use of the MyBlinker system.
- Any unauthorized use of a user on MyBlinker found during the service provided, after having been reviewed by our Customer Support team, may result in termination of the service. This includes, but is not limited to; harassment, illegal behavior, or other violations of the MyBlinker Terms of Service.
- MyBlinker customer service may cancel services based on, but not limited to, the following reasons:

**Active services:**

1. The expert arrives late and does not comply with the provisions of the agreement.

Of the above, evidence must be presented that justifies why the cancellation of the service is requested.

**Services completed:**

1. Companies that threaten to leave a harmful review to obtain more services from the expert unrelated to the agreed requirements.

Of the above, evidence must be presented that justifies why the cancellation of the service is requested.

**Refunds**

- Capital refunds (i.e. refunds directly to your payment provider) may be made by our Customer Support team, depending on the amount of the original service payment. To prevent fraud and abuse, we limit the total number of times users can request a refund from the payment provider, which is subject to review by our customer support team. Such refunds may be subject to an additional fee.
