Cookies Policy

MY BLINKER developed by HR SINAPSIS, needs to implement cookies, own and third-party, to offer its content on the web and also provide its users with a better service.

What are cookies?

Cookies are text files containing small amounts of information that are downloaded to the user's device when visiting a website. After installation, cookies can be returned to the originating website (first-party cookies) or to other websites (third-party cookies).

Cookies allow a website to recognize a user's device, facilitating their navigation, remembering their preferences and, in general, improving the user experience, helping them to offer information and services related to their interests. Cookies do not store sensitive information about you, such as credit cards or bank details, photographs, your ID or personal information, etc.

Applicable law allows us to store cookies on your device if they are strictly necessary for the operation of this site. Thus, for all other types of cookies we need your permission.

What types of cookies are there?

Below, we inform our users that this website uses different types of cookies that can be classified as follows.

According to its purpose:

Technical or necessary cookies: those strictly necessary for the correct functionality of the website.

Statistical or analytics cookies: help website owners understand how visitors interact with websites by collecting and providing information anonymously.

Personalization cookies: allow the website to remember information that changes the appearance or behavior of the website according to the user's settings.

Marketing or advertising cookies: these are used to track visitors to web pages. The intent is to display relevant and engaging ads to the individual user.

According to the time they remain activated:

Session Cookies: those that exclusively store user information for the duration of their visit to our website.

Persistent Cookies: those that retain information from users who repeatedly access our website, remembering the selected preferences.

According to the entity that manages them:

Own cookies: those managed by our website to which the user accesses and requests their service.

Third-party cookies: those placed by third-party services that appear on our website (such as Google, Youtube or LinkedIn).

Likewise, we indicate that the personal data processed through third-party cookies may be transferred to the United States, with the necessary security guarantees for the realization of said international transfers through adherence to the Privacy Shield, as in the case of Google Analytics cookies.

As a result of cookies used by third parties, your data may be subject to international transfer if you consent to their use. You can obtain more information about transfers to these countries and how they are carried out, through the corresponding policies of these providers provided here:
